PROP C ROLLBACK

- ½ OF DISTRICT PROP C \$ REDUCES PROPERTY TAX RATE
 - ONLY 58 DISTRICTS IN THE STATE STILL ROLLBACK FOR PROP C
 - 10% OF ALL DISTRICTS
 - SALES TAX INCREASE = PROPERTY TAX DECREASE
 - SALES TAX DECREASE = PROPERTY TAX INCREASE
