

## REGISTRATION INSTRUCTIONS IGNITING SCHOLARS DUAL CREDIT PROGRAM: STUDENT/PARENT

## PLEASE KEEP THIS PAGE FOR YOUR REFERENCE

- 1) All first-time dual credit students must complete an Application for Admission and a Registration form. Students who have taken dual credit courses before should complete the Registration form only.
- 2) Payment for the total amount of tuition (\$75.00 per credit hour) should be paid by Sept 15th, 2019 for Fall semester; Feb 15th, 2020 for Spring Semester. There are three methods of payment: checks may be mailed to Lincoln University, ATTN: Office of the Controller, PO Box 29, Jefferson City, MO, 65102-0029; the University also accepts VISA, MasterCard, American Express, and Discover payments either via Student Planner or by contacting the Cashier's Office at (573) 681-5085. If you are paying by check, include the Student's Name and Lincoln ID number on the check.

## The cost per course is:

3 Credit Hours - \$225.00

4 Credit Hours - \$300.00

5 Credit Hours - \$375.00

It is the student's responsibility to notify Lincoln University at (573) 681-5206 if their schedule changes and they have dropped a Dual Credit class. Failure to notify Lincoln University of any schedule changes may result in that student receiving a failing grade for that course.

- 3) Student eligibility:
- Students in the 11<sup>th</sup> and 12<sup>th</sup> grades with an overall minimum grade points average of 3.0 (on a 4.0 scale) are automatically eligible for dual credit courses.
- Students in the 11<sup>th</sup> and 12<sup>th</sup> grades with an overall grade point average between 2.5 and 2.99 (on a 4.0 scale) must provide a signed letter of recommendation from their principal or guidance counselor **and** provide written permission from a parent or legal guardian.
- Students in the 10<sup>th</sup> grade must have an overall minimum grade point average of 3.0 (on a 4.0 scale) and must provide a signed letter of recommendation from their principal and guidance counselor **and** provide written permission from a parent or legal guardian.
- Students in the 9<sup>th</sup> grade must have an overall minimum grade point average of 3.0 (on a 4.0 scale), score at the 90<sup>th</sup> percentile or above on the ACT or SAT, and provide a signed letter of recommendation from their principal and guidance counselor **and** provide written permission from a parent or legal guardian.

In addition to the above requirements, all students must meet the prerequisites of the specific course(s) in which they wish to enroll.

- 4) After you have completed the application and/or registration form(s), please return them to your instructor before the deadline below. Your instructor will forward them to Lincoln University, Division of Educational Innovation and Extended Studies.
- 5) Grades: Grades will be available after the date listed below ONLY through the Student Planner portal. **Students will not receive Lincoln University grades in the mail.** Instructions for accessing Student Planner are found on the Portal Instruction page.
- 6) Transcripts: Starting on December 1st, 2018, the Lincoln University Transcript Request Form will no longer be in use. Students can request unofficial transcripts in person only at the Lincoln University Office of the Registrar in B4 Young Hall. Official transcripts must be obtained online from National Student Clearinghouse (https://studentclearinghouse.org). The cost for each transcript is \$10, plus an online fee if ordered online. Official Transcripts are not available until two weeks after grades are posted.
