Cosmopolitan International Club of Jefferson City, Missouri Scholarship

The Cosmopolitan Club offers **\$1,000** scholarship(s) to help defray the first-year expenses at the school of the recipient's choice, whether it be a college, trade school, cosmetology school or other post-secondary education. It is not renewable, and it is not a loan.

A. Eligibility - The applicant must:

1. Be in his or her senior year of high school.
2. Not have previously attended an institution of higher learning.
3. Be in actual need of financial assistance to continue his or her education.

B. Responsibilities – The applicant must submit:

1. The Cosmopolitan International Club of Jefferson City, Missouri Scholarship application form with all questions completed. Incomplete applications will not be considered.
2. A letter of recommendation for this scholarship from an individual. This individual must be someone other than a school representative or relative. Attach letter to the application form.
3. An essay of 300 words or less, explaining your goals for the future and your professional ambitions. Explain how this scholarship will help you achieve your goals. Attach the essay to the application form.

Applications and essays will be evaluated on the following criteria:

- a. Character
- b. Citizenship
- c. Academics and Achievements
- d. Basis of need

Submit these three items to the scholarship Chairperson of the Cosmopolitan International Club of Jefferson City, Missouri. The mailing address is indicated at the bottom of the application form. **Applications must be postmarked by March 31, 2023.**
